#### New Business

### To look at, discuss and potentially approve the Congregational/Community of Faith Profile (which consists of the Living Faith Story & the Minister of Community Engagement Position Description)

David Q. gave some background around amalgamation and he also discussed our process for this meeting. The position of Minister of Community Engagement was created at the time of amalgamation as part of the TGUC Ministry Plan approved by the congregation, presbytery and BC Conference. A candidate for ministry was appointed to the position as a two year Supervised Ministry Experience (SME). After that appointment ended, hiring a new person for the position was sidetracked due to the pandemic. We are now able to resume this as part of our mission. The position has been reviewed and adapted to fit the current, post-pandemic context and ministry priorities of the congregation.

In order to move forward, we were required to create a Living Faith Story, in essence, our mission and our vision. This has been completed and approved by the Board. The Minister of Community Engagement Position Description has also been approved by the Board.

### **Congregational Meeting Minutes**

June 5th, 2022

In order to move forward, we were required to create a Living Faith Story, in essence, our mission and our vision. This has been completed and approved by the Board. The Minister of Community Engagement Position Description has also been approved by the Board. Marc Coulombe, Regional Minister, has also reviewed the documents. Once the Living Faith Story and the Minister of Community Engagement Position have been approved by the congregation, documents will go up on Church Hub, and a Search Committee with be formed in order to find an ideal candidate.

After David completed giving background on the process, there was discussion and questions were asked/answered. Some key points that came up are:

- Sandra will not be part of the Search Committee nor will she be a supervisor of the new minister (unless the congregation opts to appoint a candidate as an SME).
- The new minister will be accountable to the M. and P. committee and to the Board.
- The position may be a call or an appointment (of 2 or 3 years seeking guidance from the region about the timeline).
- This is a new position as the role is somewhat different from the last position that was filled by a student. The position may not be suitable for a student as the candidate will need to be self-directed.
- It's hard to know the timeline for hiring at this time, as it will depend upon the fit of the candidate (although we are hoping for someone to be in place by the fall).

**The discussion led to one amendment of the Position Description under Skills and Qualifications:** changed from "ability (or willingness to learn) to communicate across a wide range of digital media" TO "ability and willingness to grow skills to communicate across a wide range of digital media".

**Motion** (Rozalyn/Joanna): That the Congregational Profile, including the Living Faith Story and the position description for the Minister of Community Engagement, be approved as amended. **Carried** 

Sandra closed the meeting with a Prayer and meeting was adjourned at 1:15 p.m.



### Minister's Report

Friends, it's been another interesting year ...

When I wrote last year's message in March 2022, we were just newly back to in-person worship (again) after another Covid-related closure, and both Gracie's and Graceful Noise were just reopening in person as well.

It was a "tentative" spring. While some programs re-opened, other programs like the Community Breakfast and playgroup remained on hold. However, I was pleased that we were able to run a Lenten book study and hold our annual Maundy Thursday dinner.

The church also did some focused work on living into our commitment to social justice. During Lent we focused on awareness, learning and action on a number of issues. We were also excited to form new partnerships in the community, notably with Steven Seegerts from the Urban Aboriginal Ministry, who led a series of indigenous workshops for us, where participants made drums and learned about indigenous spirituality and culture in sacred circle.

Last summer was an opportunity to finally make plans for what we hoped would be a "nonpandemic-interrupted" church year. We had a consultant come to help us update our livestreaming set up and we also moved forward to begin the search & hiring process for our new Community Engagement Animator.

As the fall began, we welcomed Alan Lin to the staff team as our Sunday livestream facilitator. Gracie's and Graceful Noise re-opened, and an attempt was made to re-start the Tuesday Community Breakfast. However, after a few months, it became clear that the needs of the community had changed and the difficult decision was made to suspend the breakfast program indefinitely. The Board also made the tough decision not to host our Annual Christmas Carol-Sing for health & safety reasons.

However, the church did host a Swing Dance in November - a fun and successful evening, which also marked the final event in our Jazz Ministry pilot project, which had been started a year earlier and stalled due to the pandemic.

Late November also saw the start of our Fair Trade mini-fair, which ran each Sunday through Advent, accompanied by informative presentations on different vendors.

Also in December, thanks to the dedication of our Search Team, Shadia Qubti joined us as our new Community Engagement Animator. Shadia jumped right in and together we had a lot of fun hosting a Newcomers Evening and putting together a Nativity Pageant for the fourth Sunday of Advent.

## Minister's Report

In mid-January I began my sabbatical leave. It was also a time of more transitions. We bade farewell to Fanny in the office and to Melody as our Sunday soloist, then welcomed Darcy Blunston as our new Sunday singer.

As I write this, I have been back from my sabbatical for just three weeks. I am incredibly thankful for the gift of time and space to slow down, rest, renew, reflect, and deepen both my spiritual practices and theological journey. I am also incredibly grateful to Janice Guthrie and Shadia Qubti for their leadership in my absence.

My time on sabbatical has allowed me to come back and "see with new eyes" - and I am excited to see how the spirit is moving at Trinity-Grace!

We have a new website (thanks to Shadia for her work on this), our community gardens and new pollinator flower garden are flourishing, and we have several new members joining the church on this upcoming Pentecost Sunday.

With the pandemic seemingly in the rearview mirror, the church year winding down, and our renovation project slated to begin next month, our focus will shift to summer projects and planning for the fall.

Our new Office administrator, Heather Hill will be starting regular hours in June, and one of my goals will be to strengthen our staff team to see us into a good fall start-up. I am also looking forward to TGUC (for the first time since amalgamation and becoming Affirming), participating in the Vancouver Pride Parade in August!

Friends, the Spirit is doing her thing among us. May we continue to say "yes"!



Sandra, Mary Al, some of our musicians, and some of our appreciative audience have been there from the very beginning, as has been the warm atmosphere of welcome, support and encouragement to all. We operate by the guidelines of the Trinity Grace Mission, Vision and Values. Our mandate is to build community, and encourage musicians of all levels and experience to come and perform to an always appreciative audience. We understand initial shyness, and work to build confidence. We emphasize that our aim is not perfection. The result is an inspiring concert by some amazing musicians and poets.

We've grown over the years, but have been blessed to keep developing as a vibrant community, with the same welcoming, accepting atmosphere and exuberant music. Lunch is prepared and served by Deb, Keiko and Mary Al. Keiko has also joined our list of performers, and plays beautiful music often by Japanese composers. Sharon Jacobs, her friend Lisa, and Cheryl have assisted at times as well. Daniel, who also plays a mean washtub bass, has put together a great sound system. Shadia, our Community Engagement Animator, has joined Rev. Sandra in leadership, and has also contributed some lovely music. Many of the group participate in the setup and execution. Kim is our able emcee, and keeper of the order of performance – no mean task. Su makes sure the sanctuary is ready for Sunday Worship. Tammie is Daniel's faithful helper in takedown. Many others help with the taking down of tables, reorganizing of chairs, and whatever needs doing.

It's a joyful place to spend a few hours every other Saturday. Come and make new friends, listen to great music, visit Gracie's thrift store, and enjoy lunch.

# Gracie's Thrift Store Report

After 2 years of uncertainty, due to the pandemic, in January 2022, Gracie's was open for a full year.

It was a year when we recorded our highest income ever of \$22,230.

Over 2022 we had a number of on-line sales from our website store and Facebook Marketplace of unique items that were either antique or of greater value. This was made possible by large estate donations of vintage items from a friend of a congregation member and another congregant. We are very grateful that we were entrusted with their treasures and it inspired us to have an Antique and Vintage parking-lot sale in, July 2022, which brought in new customers and made them aware of the store. Also, the addition of Shadia to the staff at TGUC has been of great assistance. Her innovative ideas for connecting Gracie's to other service providers in the community has made them aware of our presence and of the other events we provide, such as Graceful Noise.

One of the first large fundraisers of the year was for Ukraine, after the Russian invasion, followed by a second fundraiser for children affected by the war. Since then we have donated household items from the thrift store, for a recently arrived Ukrainian family, and an Afghani family of 10 who arrived mid-2022. There have been occasions where homeless and rehabilitated people have received items needed to set up their newly aqquired housing, and we are now partnering with 411 Seniors Centre on Fraser St. to provide needed items, as their senior clients find themselves in difficult circumstances.

Since then, warm clothing and footwear, blankets and baby clothes were provided as Turkey experienced a massive earthquake, and the Turkish community put out an urgent request for help.


Clothing has been donated to several shelters over the past year, one of the new shelters being in the old Army and Navy Dept. Store, called the Bud Osborne Shelter. Staff were very thankful to receive a donation of men's underclothing, a rare resource, and cold-weather clothing.

After the first Hotel fires in the downtown eastside in late 2022, we delivered a large donation to Betty's Boutique, where those affected by the fire could find essential clothing and personal items.

Two new former customers, now volunteers, take on most of the deliveries to the shelters, and others deliver to WISH and SAFE shelters in the church neighbourhood. A breakfast cereal donation to the church was given to BRIDGE Housing, with enough for every person living there, and clothing, footwear and accessories to "Work Wear" for those starting a new career or their first work experience.

Two trumpets, donated by a congregan,t were repaired and later taken to a school for children in a small Mexican town, by a church member.

At the end of the summer, warm-weather clothing was donated to Kate, a woman who sends clothes to her native Ghana. Children's clothing and toys are forwarded to the Family Place, at nearby Robson Park, to an elementary school with many refugee and underpriveleged families attending, and craft and art supplies to teacher at a Vancouver School.

Apart from the in-kind donations, Gracie's was able to donate finacially to many worthwhile causes, including a scholarship for a graduating student at Sir Charles Tupper Secondary School, where we have also donated clothing,

including graduation evening wear. It's always rewarding to receive a "thank you" letter from the graduate.

In 2022 we used social media tools, Instagram, Facebook, Craigslist and Marketplace to advertise our sales, and have noticed new, younger customers, but we still retain the friends that the longterm customers have become. Such relationships inspire us to donate to other charities, such as Make-a-Wish, ALS Society, Canuck Place and Myeloma, as we learn the challenges they experience in their lives.

The introduction of the "Square", which provides debit and credit card transactions, has also helped boost sales, in this mostly cashless society . Thanks to David M. for his patience transitioning to the Square, with wifi ups and downs, and the increased volume of customers he serves

One of the highlights of the year was the washer and dryer that the Church Board generously approved the purchase of. It has made such a difference in volunteer's sorting tasks and the ability to recycle more donated clothing, meaning less in the landfill. Any unsalvagable clothing is donated as rags.

None of this work would be possible without the many volunteers, from within the church and surrounding community (too many to name here), and the donors who have chosen to bring their no-longer-needed items for sale at our "little thrift store in Mount Pleasant", and the customers who choose to shop at Gracie's.

We look forward to whatever 2023 brings and thank TGUC for allowing Gracie's to continue to operate. Blessing to you all. Sally Marcantonio Thrift Store Co-ordinator.



## Social Justice Report

In 2022, Trinity Grace continued its focus on social justice work, both local and international. Below is an outline of some of the topics and issues we learned about, partcipated in, and responded to throughout the year.

We began the year by learning about some **local social enterprises**, including 'Megaphone' and 'United We Can' – both of these enterprises help to alleviate poverty for some of Vancouver's most vulnerable citizens.

February's social justice theme was **Black History Month**. Also, for several weeks near the end of February and into March, we focused on the **war in Ukraine** and ways that we could help.

Trinity Grace began to serve **Fair Trade Coffee and Tea** April. We are buying these products from **Café Etico**, a **Vancouver based organization that is part of a larger non-profit**, **CoDevelopment Canada**.

Also, in the spring, we had a focus on **Palestine**, **through the lens of apartheid**. Marianna Harris and George Bartlett kept us updated on PalNet activities and other projects and programs related to Palestine. Also with regards to Palestine, Brenda Harrison attended the **UNJPPI Gathering** in May (held in London, Ontario) and reported back to the congregation.

Throughout the **Season of Creation**, in September we highlighted **Indigenous knowledge and practices**, and how these are being used to heal, restore and protect the land.

Our theme for October was **food security**. One great organization we highlighted was Backpack Buddies - they provide hungry kids with food over the weekend, when school breakfast and lunch programs are not in effect.

**Shadia was hired as our new Community Engagement Animator position** in November. She quickly became involved in a variety of programs and projects, including the **Fair Trade Mini-Market**, held **every Sunday throughout Adven**t. Throughout December, we also learned about a variety of Fair Trade organizations.

Throughout the year, Trinity Grace made a regular monthly donation to the local organization **WISH Drop-in Centre Society**. WISH works to improve the well-being of women who are involved in Vancouver's street-based sex trade.

"Gracie's Thrift Shop" made a regular donation to Doctors Without Borders/ Médecins Sans Frontières (MSF). Doctors Without Borders/MSF is a medical NGO known for its work in conflict zones, disasters and epidemics. Their medical teams act quickly and go where they are needed most.

The congregation was also made aware of several **Emergency Appeals** throughout the year, including one for floods in Pakistan and another for drought in the Horn of Africa.

Various advocacy opportunities regarding a number of current issues were also presented, including petitions and letter writing.

Several updates about the ongoing First United redevelopment were also provided.

We look forward to what the rest of 2023 will bring regarding social justice education and actions.

I started the Community Engagement position halfway through the last quarter of 2022. During this time, with the help of TGUC board and staff, I was introduced to the existing community engagement programs and networks.

It has been a steep learning curve engaging with TGUC's programs - the weekly Tuesday Breakfast, Gracie's Thriftstore and Graceful Noise Coffeehouse - as well as TGUC's network - the Mt. Pleasant Food Network and Interfaith Alliance.

During Advent season, a collective effort to demonstrate our commitment to the six social justice issues in different programs, activities and communications. In addition to what was mentioned in the other report, in collaboration with PalNet, we participated in an online 4 week Christmas Advent webinar.

### **Trustees Report**

The trustees are appointed to oversee matters related to the church property. To ensure stewardship of property, the main areas of oversight are investments, taxes, insurance, property renovations and maintenance and land sale/acquisition. The current trustees are Robyn Brasell, David Marcantonio, David Quan and Sandra Nixon (ex officio).

2022-23 has been relatively quiet. The highlights are as follows:

- As expected, due to market conditions, the Investment returns for the period ending December 31, 2022 were -10.9%, resulting in a loss of \$365,887 (with 51,026 of that being realized income, 397,862 as unrealized income and 19,051 as management fees). Last year, we had a return of 11.9% so it's essentially net zero when you compare the balances year to year.
- The insurance is up for renewal in May. Last year's premium was \$7741. We are awaiting this year's quote, which we expect to be the same or higher; it will likely be higher but we don't know how much at the moment. The budget reflects a conservative guess for this increase.
- The estimated amount budgeted for the building renovation is \$50,000 – 70,000. This was revised from the original \$150,000, which was allocated for a much more complicated renovation.

Big picture, despite the loss in the value of our invested funds, we are still in a relatively healthy situation. As it has in the last few years, the legacy Trinity United fund continues to enable us to do our work in the church and in the wider community without worrying too much about how to pay the bills.

Nevertheless, we will always aim to be efficient in our spending. The hope is that the market condition improves and we will enjoy returns similar to what we've been receiving the last few years.

# Treasurer's Report

- \* The accompanying financial statements represent Trinity-Grace United Church 2022 results of operations, compared to results for 2021.
- \* The budget sheet Schedule 1, presents the Budget for 2023 compared to actual results 2022. Schedule 2 sets out notes and assumptions in creating the Budget for 2023.
- \* A revised Budget will be prepared for review and approval in the event programs are added or changed before the date of the Annual Meeting.

#### Significant Items in 2022

- \* We re-hired the Community Minister position effective November 2022.
- \* We have a contract person as a resource for audio-visual during in-person worship.
- The actual result for 2022 is net operations costs of -\$(630,098). The main portion of the loss is the investments net market decrease -\$(365,887) due to volatile market investment conditions.
- \* \$270,000 was withdrawn in 2022 from invested funds in order to finance 2023 operations.
- \* Loss in market value of invested funds are a significant factor in 2022.

#### Thrift Store and Donations - Special Note Thrift Store operations moved from on-line to add 16 "in person sales" dates and raised \$22,230. We plan to continue the on-line presence for this outreach. Donations of \$20,491 added to TGUC Missions and Service, Advent Donations and MAP Van

Donations of \$20,491 added to TGUC Missions and Service, Advent Donations and MAP Van donations for a total of \$23,201 for the year.

Clothing and essential supplies were also donated throughout the year. **Notes for 2023** 

- The office administrator left in January 2023, We have a part time support person for this position and hours may be expanded as 2023 continues.
- \* Re Investments. We have a break-even position estimated for 2023. The investment projection will be updated as we are advised of current performance.

1 Amalgamation and Nature of Operations

Grace Memorial United Church and Trinity United Church amalgamated as Trinity - Grace United Church effective January 1, 2018.

Each member of the amalgamation is constituted from long-standing congregations; the congregations having been established under The United Church of Canada, as provided in The United Church of of Canada Act, 1925.

As with other United Church congregations, the congregation is not incorporated. The congregation constitutes an internal division of the national incorporated body and, in addition, maintains individual charitable status.

#### 2 Significant Accounting Policies

Land and buildings are owned by the Trustees for the Church and are contributed from the former Grace Memorial United Church. The balance sheet reflects a nominal value of \$1.00. At the date of amalgamation the assessed value of the land and buildings, as reflected in the annual report of BC Assessment records is approximately \$5,019,800.

Musical instruments and equipment are recorded at cost. Assets are depreciated on the declining balance basis at rates indicated below. In the year of acquisition one-half of the normal rates are applied.

4 The Congregation is assisting to administer funds on behalf of Palnet Organization, an agency working for Human Rights in Palestine / Israel. At December 31, 2022 \$11,771 of Palnet funds are included in total funds within the Trinity-Grace operations account. Palnet Organization is a program sponsored by Pacific Mountain Region, United Church.

#### 5 Invested Funds and 2022 Property Renovations

The Ministry Plan approved by the Congregation at date of amalgamation included prospective plans for redevelopment of the capital property along with short term minor updates. An amount of \$280,000 was noted as an estimate for this purpose.

The Congregation approved the 2022 plan to renovate the Sanctuary and create a new meeting space. The estimated cost of these renovations is \$150,000. Structural work will commence in spring 2023.
